



**Contract for the Limited Recreational
Use of the Campus Lake
June 3 through July 31, 2019**

I understand that the St. Andrew's-Sewanee lake (known as "the Res") exists for the use of the school, its programs and personnel. I agree to forego my use should this be required at any time by the school. I understand that prior to **June 3** and after **July 31, 2019**, the Res is reserved for the use of current St. Andrew's-Sewanee students, faculty, and staff. No outside use is permitted.

I understand that I may use the Res, which belongs to St. Andrew's-Sewanee School, **from June 3 - July 31** for recreational purposes. Only holders of a valid **2019 Res Pass** may use this facility during that time-period. Pass holders may bring no more than **three (3)** guests. Users should carry the Res Pass with them while visiting the lake and should display the parking permit when parked at the Res or at the school parking lot adjacent. Those breaking any of the rules may be prosecuted.

I agree to abide by the following regulations, for my own safety and the safety of others:

- No one may swim alone.
- No rope swings may be installed or used.
- Use is permitted only between dawn and dusk each day.
- Minor guests must be accompanied by someone over 21.
- No glass containers, alcoholic beverages or any illegal substance may be brought to or consumed at the Res.
- Fireworks, firearms and other weapons are not permitted.
- Smoking and fires are prohibited.
- Trash is not to be thrown in the water or left on the grounds.
- Conduct befitting a school environment will be displayed at all times.
- Res pass holder must have pass with him/her when at the Res and display a Visitor's Parking Permit in the left rear window of their vehicle.
- Dogs are not allowed at the Res.

I hereby expressly agree to release, waive, discharge, hold harmless, defend, and indemnify St. Andrew's-Sewanee School against any claims or liability for any and all injuries my guest(s) or I may suffer to my person or property while on the property, including those arising from the negligence of St. Andrew's-Sewanee School or any of its employees, agents, students, or guests. This waiver and release is in addition to any other immunities or defenses to liability that are available by law to St. Andrew's-Sewanee School.
